No rebate will be awarded based on HVAC dealer bid specifications, promotional material of dealer, manufacturer or any other source than ARI. A certificate of ARI-certified performance must be submitted. ALL homeowners must complete a rebate request form and provide proof of purchase within 30 days of equipment installation to receive any 2012 Southern Indiana Power rebate.

ALL homeowners and future homeowners receiving Southern Indiana Power rebates agree to the future installation of energy management devices on these rebated appliances (with the exception of heat pump water heaters) to allow Southern Indiana Power to engage in future energy management procedures.
